CLEANHYPRO OPEN CALL FAQs

PREPARING YOUR APPLICATION

1. How do I apply?

A: Here are some guiding steps to follow:

1. Visit our [website](#) and check the [Guidelines for Applicants](#) and download the [proposal template](#).
2. Fill in the template with your proposal.
3. Then, go to the application page on the F6S platform [here](#) and click on *Connect with Mariale, Raquel and Michalis by Dec 18*. Fill in the application form and upload your proposal.

2. How do I sign in to the F6S platform to submit my application?

A: If you are not registered to the F6S Platform yet, you will need to create a new profile by following these steps:

- Go to the [F6S main page](#) and you will see the **Join box**
- Select [Continue with Google](#), if you want to register with your Google account
- Select [Continue with email](#), if you would like to register with an email account
- Then, a new page will open asking you to add your name, surname, email address and password
- When applying to the Call, if user is not registered, the link usually redirects to the registration page

3. Who is eligible to apply to the CLEANHYPRO Open Call?

A: The call is open to any legal entity holding trade licenses (large enterprises, SMEs and natural persons) established in a [Horizon Europe country](#).

4. I discovered an error in my application, can I submit it again?

A: Yes, you can resubmit your application in the F6S platform provided the call deadline has not expired. Only the last version of your proposal before the call deadline will be considered for evaluation. For this purpose, you are required to send an email to support@f6s.com requesting to reopen your application. Nonetheless, we highly recommend you carefully revise your proposal before submitting it.

5. Do I have to sign the Democase Collaboration Agreement (DCA) when applying for the Open Call?

A: No, you just need to confirm that you have reviewed and understood the DCA who you can find in the [Guidelines for Applicants](#). The DCA is a preliminary legal contract between the beneficiary and CLEANHYPRO service provider, but at the application stage there is no legal commitment.

AFTER APPLYING

6. How do I know if my proposal was successful?

A: Applications will be reviewed and evaluated, and you will receive an email from us 4 weeks after the call closes. The first wave results are expected in mid-January 2026.

7. If my application was not successful, would I still receive a notification?

A: Yes, all applicants will receive an email with their evaluation report.

8. What's next if my project was selected?

Your project will be assigned a Service Delivery Manager (SDM) from members of the consortium. With the SDM you will be able to co-create a Service Delivery Plan (SDP) before the start date of your project. In this period the DCA will also be signed.
